**WESTFIELD MEMBERSHIP/FITNESS MEMBERSHIP  
WAIVER AND RULES OF MEMBERSHIP**

1. **MEMBER'S HEALTH WARRANTY:** The Member warrants and represents that the Member has no disability, impairment, or ailment preventing her/him from engaging in active or passive exercise or that will be detrimental or adverse to such a person's health, safety, or physical condition if she/he does so engage or participate. The Member acknowledges and agrees that:
  - a. YWCA Westfield will rely on the foregoing warranty in issuing the Membership;
  - b. YWCA Westfield shall have no obligation to perform a fitness assessment or similar testing to determine the Member's physical condition; and
  - c. YWCA Westfield shall not be liable for any injury arising from the Member's disability, impairment or ailment preventing her/him from engaging in active or passive exercise, or that would be detrimental or adverse to such person's health, safety or physical condition if she/he does so engage or participate.
  - d. Each Member should be aware of her/his medical history and should consult a physician prior to engaging in exercise or continuing to exercise if a medical condition appears or appears to be developing.
2. **LIABILITY AND WAIVER OF LIABILITY:** Each member of YWCA Westfield shall be liable for any Property damage and/or personal injury (caused by a Member, Member's Family, Guest or any other person) at YWCA Westfield or any activity or function operated, arranged or sponsored by YWCA Westfield. It shall be the obligation of the Member to pay for any costs involved upon presentation of a statement thereof. Any and all use of YWCA Westfield fitness facilities, or participation in YWCA Westfield activities operated, arranged or sponsored by YWCA Westfield either on or off YWCA Westfield premises by the Member, Member's family or guest(s) shall be AT SUCH PERSON'S OWN RISK, and YWCA Westfield shall not be liable for any injuries or damages to such a person, or the property of such a person, or subject to any claim, demand, injury or damages. The Member Individually, or on behalf of the Member's personal representative, heirs, administrators, assigns and successors does hereby expressly forever release and discharge YWCA Westfield, its successors and assigns as well as its officers agents and employees from all such claims, demands, actions, or causes of action.
3. **SUSPENSION/TERMINATION OF MEMBERSHIP BY MANAGEMENT:** Management has the right to suspend and/or terminate any membership for non-payment of dues, or for behavior inimical to the enjoyment of YWCA Westfield by other members and staff for any reason deemed sufficient in the sole discretion of Management.
4. **MISSION:** I understand that membership supports and furthers the Mission of the YWCA Westfield.
5. **SECURITY:** I understand that the PIN number assigned to my fitness membership is for my use only and that use of my PIN number by anyone other than myself will result in my PIN privileges being immediately revoked.
